Description: If the vehicle is driven under repeated start and stop operation in extremely low ambient temperatures and in deep snow, there is a possibility that snow may accumulate in large quantities inside the rear wheel and freeze. Due to the shape of the rear brake tube, the snow frozen inside the wheel may contact the rear brake tube during wheel rotation.

In the worst case, if this condition occurs frequently, the rear brake tube could be damaged, which could result in leakage of brake fluid, causing a decrease in brake effectiveness.

Remedy: Any Toyota dealer will inspect and, if necessary, replace the rear brake tubes at NO COST to you.

Description: In certain 2001 through early 2002 model year ECHO and Prius vehicles, the connector for the Crankshaft Position Sensor may become disconnected.

In the worst case, if the Crankshaft Position Sensor becomes disconnected while the vehicle is being driven, the engine will stall and will be unable to restart, thus increasing the possibility of a crash.

Remedy: Any Toyota dealer will replace the Crankshaft Position Sensor with an improved one at NO CHARGE to you.

First Owner

New Owner Reported

When a vehicle is sold to a new owner, the Title must be transferred to the new owner(s) at a Department of Motor Vehicles.

Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico. Dealers sometimes opt to take ownership of a vehicle and are required to in the following states: Maine, Massachusetts, New Jersey, Ohio, Oklahoma, Pennsylvania and South Dakota.
